**Agreement for Contractual Reengagement for Clerical Post of Group-C Category in the offices of District Magistrate & Collector, Purulia and also the offices of the LR set up of the district.**

This agreement is made on the .....day of the month of .....of the year 2012 between Sri ..... aged about..... (Date of Birth ..... ) S/o .....of Vill..... P.O..... P.S..... Dist..... Full address to be given (Hereinafter called the employees) of the one part and District Magistrate & Collector, Purulia (Name and designation of appointing authority) having his office at Purulia P.O Purulia, Dist-Purulia, Pin:723101 (Office address to be given) (Hereinafter called the Employer) of the other part.

Whereas, it is agreed and declared as follows.

1. That Sri.....Shall be reengaged on contractual basis to the post of Clerical post of Group-C category as order no. 8432(23)-B-III/ISU/2P-171/11 dated 14.12.2011 of the Land & Land Reforms Department, Govt. of West Bengal, read with Finance Department's memorandum vide no. 10935-F(P) dated 5.12.2011. The contractual reengaged shall be valid upto one year from the date of reengagement or till the reengaged employee attains the age of 65 years, whichever is earlier.
2. That the said reengaged retired employee shall receive a consolidated monthly remuneration of Rs 10,000/- (Rupees ten thousand only) or the remuneration applicable to a reemployed retired employee as per Finance Departments G.O. No. 3951-F dt. 27.05.2009, whichever is minimum, after expiry of every English calendar month. However, if the period of contractual reengagement falls short of a month, the remuneration payable to the reengaged retired employee shall be calculated on pro rata basis and paid to the re-engaged retired employee accordingly.
3. The District Magistrate, Purulia/ the Sub-Divisional Officer, Purulia who will be the Drawing and Disbursing Officer of the reengaged retired employee shall pay the said consolidated contractual monthly remuneration to the reengaged retired employee out of the funds received from the Land & Land Reforms Department, Writers' Buildings, Kolkata- 700001 and be debited from the detailed head " 02-Wages" under relevant head of account.
4. That the reengaged retired employee shall faithfully, honestly, impartially and diligently discharge his assigned official duties. But, if the reengaged retired employee himself absences from his assigned official duties without leave or is found guilty of misconduct or commits any breach of terms this contractual reengagement the employer shall be at liberty to terminate his contractual reengagement at any moment as and when required without assigning any reason whatsoever to the said retired reengaged employee and the employer shall always be at liberty to sue reengaged retired employee in the Court of Law in case of breach of law committed by the said retired reengaged employee and the employer will be at liberty to claim compensation for such breach or violation.
5. That either of the parties of this agreement will be at liberty to terminate this contractual reengagement by giving one month advance notice to the other side before the stipulated date.
