NOTICE INVITING TENDER

Sealed Tenders are invited from the SHG/SANGHA/ Government organization such as CADC etc situated / resided at Hura block (vide approved note sheet of District Magistrate, Purulia dated 09.11.2017) Purulia, having sound financial capacity/Credential, to offer rate in relation to supply of goats in Government Schemes with the following terms and condition:-

1. Details of Animal to be purchased:-

Validity of rate	One year from the date of issuance of work order or until further order in this respect whichever is earlier under special prospects.	

1. The rate to be offered for each male goat is maximum Rs.3000/- & female goat is maximum Rs.2000/- including procurement, loading, un-loading, transportation, and quarantine management for 15 days at his door step after Deworming and vaccination executed by the ARD team, Puncha. After that ARD team, Puncha along with the concerned SHG/SANGHA Members etc. shall identify goats, calculating 50 % extra goats in addition to actual requirement. The tenderers must include in their tender prices quoted for all duties royalties, cess and GST or any other taxes or local charges if applicable. The rates shall also include sales tax on works contract as per Government norms. No extra claim on this account will in any case be entertained.

2. One year insurance of the goats by tagging with certificate and other charges like I. Tax ,GST etc if any for one unit within Rs.630/- this payment will be released after submission of policies..

3. The rate must have to be written both in words & figures without any over writing. If any correction made there, that should to be attested with the signature of participant.

4. The offer rate must quote their own pad and the rate must not exceed @Rs.11630/- per unit including insurance & tagging charge

5. Accepted SHGs / Sangha / Government organization have to procure Animals within 7 (seven) days for carrying Deworming and Vaccination to be executed by the ARD Team Puncha and so that supply to be done after quarantine period 15 (fifteen) days from the date of issue of supply order.

6. The disease free Animals duly certified by the Veterinary Officers will be supplied to the beneficiaries.

7. Supply should be made at any point of operative area as guided by the undersigned time to time or mentioned in the supply order.

8. The Tenderers must submit their quoted rates in sealed envelope at the tender box at the office of the undersigned situated at the address given at the top of this notice on or before 03/01/2018 by 3.00 P.M and same will also opened on 03/01/2018 at 3.30 P.M when either the Tenderer or any one authorized person on his behalf may be present.

9. Suppliers if approved have to maintain Government norms during transportation of Animal.

10. The undersigned will not bear any responsibility on receiving the letter for such enlistment of name at the office of the undersigned after due date.

11. The value of the Tender Form is Nil i.e free of cost.

12. Earnest Money deposit (EMD) @ 2% of the total cost, is to be deposited by the tenderer with the tenders as Demand Draft / Bankers cheque in favour of " Block Development Officer, Pucha". EMD deposited by the unsuccessful tenders will be refunded by way of handing over the original Demand Draft/ Bankers Cheque duly endorsed by the Competent Authority. The Earnest Money of the Successful Tenderer will be adjusted against the Security Deposit. Under any circumstances, the undersigned will not be liable to pay any interest on the EMD.

13. The Successful Tenderer should deposit Security Deposit @ 5 % of the Gross Amount of the work as Fixed Deposit / Term Deposit for minimum seven months. The said will be released after satisfactory supply after six months. The already deposited earnest money amount is to be adjusted with the Security Deposit.

14. The Statutory deduction of income tax / sales Tax as applicable on works contract will be deducted from all interim and final payment to the contractor.

15. The undersigned reserves the right to accept or reject any or all letters for enlistment without assigning any reason whatsoever. The undersigned or assigned designated person may withdraw any work order as a whole or any part at any point of time if situation demands and under unavoidable circumstances after issuing prior notice.


