TENDER NOTICE FOR SOIL CONSERVATION WORKS

Sealed tenders are invited from the bona fide and resourceful local contractors having experience in similar type of works for execution of the following soil conservation schemes in different localities of Purulia district. The tenders should reach the office of the undersigned i.e. Assistant Director of Agriculture (Admn.) Soil Conservation, Purulia by **28.01.2020** up to 1.00 pm and will be opened at 2.00 pm on the same date in presence of the tenderers or if thereby any. A schedule indicating the location and approximate volume and cost of works to be executed therein is enclosed. Application for collection of tender papers with all relevant documents (self attested photocopies of valid professional tax clearance certificate, PAN card, IT return and other relevant documents including GST registration along with credentials, etc. supported by the payment certificate within the last five financial years for an amount equivalent to 50% of the estimated value put to tender duly verified with the original.


WORKS:

Earth works including lead and lift on all types of soil, construction, contour bounding, bench terracing, desiltation basin, gully plugging, Check Dam, water harvesting structure, farm pond, land leveling etc. will have to be executed in different schemes as per specifications laid down in the schemes. The earth work includes consolidation and dressing of bunds according to specification and sites shown

CONDITIONS:

1. The authorities reserve the right to reject any or all the tenders without assigning any reasons and will not be bound to accept the lowest or any tender. The work may be distributed amongst more than one contractor if found necessary.
2. Tenders should quote rates separately for each of the soil conservation schemes and for different items of works mentioned in schedule in prescribed form.
3. The cost of the tender fees to be deposited before issuing of the tender paper.
4. Treasury challans showing deposit of Earnest Money (2.5% of the total Estimated Cost) as noted against each scheme will have to be enclosed along with the tenders. (Earnest money to be deposited in the form of **Bank Draft** in favour of the **Asst. D.A. (Admn.) Soil Conservation, Purulia**. Earnest money of unsuccessful tenders will be returned in due course.
5. Earnest money will be treated as security money after acceptance of tender and the same will be forfeited and tender will be cancelled in case of breach of contract, unsatisfactory work or delay in completion of work. Security money will be returned three months after satisfactory completion of work.
6. The work will have to be started within seven days from the date of receipt of work order and must be completed within the specific date mentioned in the work order.
7. No Running Account Bill will be paid under ordinary circumstances.
8. The authority also reserves the right to make any alteration, in the volume of work and the specification of any scheme if it is considered necessary in course of the progress of work.
9. No work order will be issued to the contractor concerned unless he executes an agreement for condition of contract of the work.
10. Details of plan and estimates of each scheme may be seen in the office of the undersigned or in the office of the concerned Asst. D.A. (Soil Conservation.) during office hours on request.
11. The beneficiary tenderers will get preference if they agree to execute the work at the lowest tender rate.
12. For the schemes where beneficiary's contributions are necessary, the portion of the schemes consisting of beneficiary's contribution will be first executed by the beneficiary/ beneficiaries.
13. If any local strike/ bandh falls on the tender date, the tenders will be opened on the next working date at the same time.
