 - (a) The bidders shall have satisfactory completed as a **prime agency** during the last 5 years from the date of issue of this notice at least one work of similar nature under the authority of State/Central Govt., State/Central Govt. under taking, Statutory bodies constituted under the statute of the Central/ State Govt. & having a magnitude of 30 (Thirty) % of the amount put tender. The completion certificate & detail communicational address of the client must be indicated in the credential certificate. (Non-Statutory Documents)
- 3) P. Tax deposit challan for the year of 2015-16 / 2016-17, PAN Card, VAT Registration Certificate has to be accompanied with the technical bid document. (Non-Statutory Documents)
- 4) Registered Partner Ship Deed in case of partner ship firm has to be submitted. The Company shall furnish the Article of Association & Memor&um. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender.
