The food grains should be of sound merchantable quality, dry, clean, wholesome, of good food value, uniform in colour and size of grains and free from moulds, weevils, obnoxious smell and all kinds of admixtures and impurities. Interested suppliers may offer rates for the food grains separately in the prescribed format within the tender schedule given below:

Terms and conditions:

For e-filing of tender, the intending tenderer may download the documents from the website <http://wbtenders.gov.in> and submit bid directly with the help of digital signature certificate and the earnest money has to be dropped at the tender box within the scheduled date and time given in this notice inviting e-tender.

1. The rate should be quoted in words and figure per quintals of the items and the rate should be given including the transportation charges for door step delivery to the 18 MR Distributor points of Purulia District.


Each tender must be accompanied with an **Earnest Money of Rs. 10, 000/- (Rupees: Ten thousand) through NEFT/RTGS on Net banking from E-tender portal.**

3. Self-attested photocopy of PAN card, trade license and latest return of income tax, GST are to be attached with the tender paper.
4. Delivery order will be issued by the District Controller, Food & Supplies, Purulia.
5. Selected supplier will be allowed seven days time from the date of issue of respective delivery order for completing delivery to the points of destination advised. In case of delay, alternative supplier may be engaged and action will be taken against the supplier for which excess cost of the alternative supplier arrangement may be recovered from the pending bill of the selected supplier.
6. The volume of work to be assigned to the selected supplier during the contract period cannot be specified definitely.
7. The authority reserve the right to appoint more than one supplier and distribute the work among them as the authority may deem convenient.
8. Final payment will be made after successful completion of the entire work with satisfaction of the undersigned and submission of the bills in duplicate.
9. Weight of food stuff at the time of delivery at Distributor godown be verified and short weight, if any, is to be mentioned in the challans by the consignee.
10. For all disputes arising regarding to the interpretation, operation the arbitration of the District Controller, Food & Supplies, Purulia is final.
11. The District Controller, Food & Supplies, Purulia reserves the absolute right to accept or reject any or every tender including the lowest one and without assigning any reasons whatsoever.
12. The rate quoted shall be written in ink and in words and figures. No over-writing shall be accepted. Any correction has to be authenticated by the tenderer under his dated signature.
13. Tax deduction will be made as per Govt. norms.


