2. Rate: Rate for handling shall have to be quoted within the maximum ceiling of 390% ASOR.
3. Appointed Handling cum Preservation Contractors shall have to undertake the job of handling of procured stock as well as maintenance of its quality in terms of memo no. 510(18)FP/IL-09/2015 Dated: 18.09.2015
4. Individuals/partner/partners of a partnership firm, Director/Directors of a private limited company etc. holding a licence under Food and Supplies Department as M.R. Dealer/M.R. Distributor or dealing in BPL/AAY wheat for conversion into whole wheat atta by execution of agreement, Rice Millers, owners of any private Godowns will be ineligible for being appointed as Handling cum Preservation Contractor.
5. Intending tenderers shall have to deposit an earnest money of Rs.5000=00 (Rupees: Five thousand) only in the form of D.C.R./Demand Draft issued by the State Bank of India or any other Nationalized Banks in favour of District Controller, Food & Supplies, Purulia,
