

## Terms & Conditions of engaged Supervisor in JALATIRTHA Scheme

1. The check dam site should be visited at least once in a week and the work progress is to be recorded in the Work Measurement Note Book (WMNB) issued from this office periodically with Signature & date.
2. It is to be checked whether the work is executed by the contractor as per the plan, specification, design/drawing and estimate of works mentioned in the approved Detailed Project Report (DPR).
3. Divisional Forest Officer, Kangsabati North Division or his authorised representative is to be informed about the progress and quality of the work positively twice in a week and time to time.
4. In case of any deviation observed in the field, it is to be informed to the undersigned or his authorised representative immediately.
5. The quality and quantity of materials like cement, sand, brick, rod etc. should be checked thoroughly.
6. The construction of check dams are scheduled to be completed within this financial year. Payment will be made in full only after completion of the work.
7. Taxes will be deducted from payment as per the applicable Rules.
8. The undersigned reserves the right to cancel any application without assigning any reason.
9. The undersigned is not bound to accept the lowest quotation rate. B. Tech Engineer shall be preferred over diploma engineer.
10. During the progress of the work, if the performance in supervision work of the construction of check dams is found not satisfactory or if the integrity is found in question, the undersigned may cancel the work order. In that case, no part payment will be made.
11. No separate transport cost or facility will be provided. The quotationer should consider transport cost & all other relevant expenses during offering the quotation rate.
12. The quotation inviting authority will not be responsible for any kind of damage occurred during the execution of the work.
13. All working tools will have to be arranged by own cost.
14. Work should be started from 2 (two) days from the date of issuing work order, failure of which work order will be cancelled & will be offered to the next bidder.
