
The same will be opened on 15.09.2016 at 1.00 P.M. Tenderer should quote a common rate in the Tender in case of supply of Ranginee Brood lac to the centres mentioned below.

1. 2500 K.G. Approx 15.09.2016 upto 12.00 noon 15.09.2016 at 1.00 P.M

The Brood lac will be distributed to selected SHG members/approved list of poor Lac cultivators, who have already done the pruning of their host plant i.e. palas/ber tree for inoculation. The list of SHGs for distribution of broodlac has already been prepared. The quantity of brood lac mentioned, may increase or decrease.

- 2. Place of supply: All the place of lac growing areas including LWE Blocks of Purulia District.
- 3. If the date of opening Tender happens to be Bandh/Holiday, Closing day, the Tender will be opened on the next working day. The time and venue will remain same.
- 4. This office shall not be responsible if the Tender are lost delivered, late by post.
- 5. Rate: Tenderers will have to quote a common rate for per quintal/Kg. including Transporation,carrying, packing,selection,loading,unloading etc. For supply of Ranginee Broodlac to the consignee of different places of Growing areas including LWE Blocks mentioned above.(Sl. No.-2)
- 6. Earnest Money: Rs.5000/-(Rupees Five Thousand). Tenderer not accompanied by requisite earnest money will be summarily rejected. The Earnest money should be in the form of Bank Draft in favour of General Manager, D.I.C. Purulia.
- Security Money: Successful tenderer should deposit 10% of the face value of the works required security money including deposit earnest money in the form of Bank Draft in favour of General Manager D.I.C. Purulia and date fixed on 22.09.2016.
- 8. Income Tax will be deducted as per Govt. Rule from the total amount of the claimed bill if valid documents in support of exemption of Income Tax is not produced. Copy of PAN card must be submitted.
- 9. Venue of Opening Tender: District Industries Centre ,Collectorate Compound, P.O. & Dist-Purulia.
- 10. Tender Committee reserves the right to cancel the tender without assigning any reason. General Manager, D.I.C.Purulia reserves the right not to place purchase order at all or place Purchase order to approved Tenderers for partial supply.

- 17. No advance payment will be made to the accepted/approved Tenderer. Earnest money and security money of Tenderer will be refunded after 15(Fifteen) days from the date of completion of work subject to condition as laid down in condition no-1 of contract.
- 18. Approved and accepted Tenderer will have to find himself to complete the work within scheduled time as asked by the undersigned
- 19. Approved tenderers will have to follow specification of the work strictly.
- 20. Specification of work: Supply of Ranginee Broodlac during Oct-Nov 2016 Season.
- 21. Ranginee Broodlac having healthy appearance and containing living mature cells more than 95% and showing 5% to 8% larval emergence out of total existing mature cells on the date of delivery will only be accepted by the consignee of the different places.
- 22 The length of the stick having healthy Broodlac will be from 6" to 8" (Six inches to eight inches).
- 23. Supply of Broodlac will have to be made in packing of new bamboo busket fastened over with gunny bag and each busket must have contain 20Kgs of healthy Broodlac covered with gunny bag lid on the top.
- 24. The Packing of Brood lac must be satisfactory of the consignee.
