- This office shall not be responsible if the Tender are lost delivered, late by post.
- Rate: Tenderers will have to quote a common rate for per quintal/ kg including Transportation, Carrying, Packing, Selection, Loading, Unloading, etc. for supply of Kusmi Brood Lac to the consignee of different places of Lac growing area.
- Security Money: Successful tenderer should be deposited 10% security money of the face value in the form of Bank Draft in favour of General Manager, DIC, Purulia including Earnest Money
- Income Tax, Cess & GST (if applicable) will deducted as per Govt. rule from the total amount of the claimed bill at the time of payment.
- The tenderer should be submitted PAN, Earnest Money, IT Return (AY 19-20), etc./ Last Audit Balance Sheet & Co-operative Registration Certificate (only for co-operative societies).
- Venue of Opening tender: District Industries Centre, Purulia, Collectorate Compound, P.o.&Dist: Purulia.
- Tender Committee reserves the right to cancel the tender with assigning any reason.
- Concerned authority will not to be responsible for any misprinting by the concerned News paper.
- Deposition of security money and Earnest money in case of Co-operative societies, Govt. Institution, State (Govt.) Corporation, Govt. Under taking etc. will be Guided by existing rules (Govt.). In case of exemption of Earnest money and Security Money valid documents will have to be attached along with Tender paper validity of supportive documents in respect of exemption of security money.
- Approved tenderers will have to supply Kusmi Brood Lac to the places as would be mentioned in purchase order.
- Time of completion of work: The supply of Kusmi Brood Lac should be made within 48 hours (Forty Eight) from the date of emergence of Kusmi Brood Lac
- Place of supply: As would be mentioned in the work order.
- Condition of supply: In case of any failure in performance of supply or break of supply or shortfall of less than 50% then the total deposited money (Earnest & Security Money) as may be forfeited without assigning any reason.

18. Kusmi Brood Lac having healthy appearance and containing living mature cells not less than 95% and showing 5% to 8% larva emergence out of total existing mature cells on the date of delivery only be accepted by the consignee of the different places.
19. The length of stick having healthy Brood Lac will be 6"- 8" (Six inches to Eight inches).
20. Supply of Brood Lac will have to be made in packing of new bamboo basket fattened over with gunny bag and each basket must have to contain 20 kgs. of healthy Brood Lac cover with gunny bag lid of the top.

The packing of Brood Lac must be satisfactory of the consignee.
