The District Magistrate, Purulia, invites item rate tenders through e-tender process for supply of Commercial LPG Stove & Lighter for various Primary & Upper Primary Schools of Purulia District for reputed and resourceful manufacturers/ authorised distributor/authorised dealers/agencies/suppliers that satisfy the terms and conditions.

2. Terms & Conditions:

In the event of e-filling, intending bidder may download the tender document from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificates. The documents submitted by the bidders should be properly indexed & digitally signed.

- I. The Tenderers should submit the copies of following papers duly self attested as technical bid documents-
 - a) GST Enrollment documents.
 - b) PAN & Income Tax Return (up to date).
 - c) Sales Tax clearance certificate.
 - d) Professional Tax clearance certificate.
 - e) Trade License.
 - f) Credential Certificate for work in similar nature of supply/work within 3 years at State Government of West Bengal/Central Government Offices, minimum amounting Rs 10000000/- (Rupees One Crore only) in a single work will be required. The completion Certificate and detailed communicational address of the client must be indicated in the Credential Certificate. Supply Orders will not be considered as Credential Certificate.
 - g) Registered Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association and Memorandum. Where an individual person holds a Digital Signature Certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for on behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender.
 - h) For any kind of exemption, on the above mentioned required documents, the bidder shall have to submit authenticated document from competent authority, in support of his claim, at the time of submission of technical Bid. No claim on a later stage will be entertained. However, the final decision regarding this will be made by the District Magistrate, Purulia.
- II. Before final printing sample registers has to be produced this office for acceptance.
- III. Joint venture will not be allowed.

- IV. No arbitration is allowed in this contract.
- V. Rate should only be quoted for overall item(s) inclusive of all taxes, delivery charges up to District Mid day Meal Cell.
- VI. All taxes will be deducted as per existing norms.
- VII. The payment will be made through RTGS /NEFT after receiving satisfactory supply reports from all concerned. No claim whatsoever for delaying payment, if any will be entertained.
- VIII. During Scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufactured/fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- IX. The authority reserves the right to cancel the NIT due to unavoidable Circumstance and for that no claim will be entertained. Any objection to technical bid must be raised in writing within 48 hours after uploading technical bid and after no claim shall be entertained in any circumstances regarding technical bid.
