Notice Inviting E-tender No. 01 / Planning Section / 2020-21 Dated: 12/07/2020

1. District Magistrate, Purulia is inviting E-Tender (Technical & Financial Bid) from eligible bonafide bidder having requisite credentials up to 12:00 Noon of 21/08/2020 for the works as mentioned below.
2. The intending bidder can see the bidding documents from the internet site www.purulia.nic.in & www.Puruliazp.in but they have to download/ submit their documents and rate in: <http://etender.wb.nic.in>
3. Bid documents consisting of qualification information and eligibility criterion of bidder, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the agency can be seen in the above websites.
4. Technical bid will be consisting of following document
 - (i) Earnest money to be deposited in favour of District Magistrate, Purulia through NEFT.
 - (ii) GST Enrollment documents
 - (iii) Income Tax clearance certificate & PAN
 - (iv) Professional Tax clearance certificate
 - (v) Credential certificate
5. The financial bid should contain the rate offered by the agency as per schedule of work.
6. Technical Bids will be opened at 12.00 Noon on 24/08/2020 in the office of District Magistrate, Purulia (Planning Section). If the office happens to be closed on the date of opening of the bid as specified, the bid will be opened on the next working day at the same time and venue. Financial bid of the bidders will be opened after evaluation of the technical bid.
7. The bidder should submit the credential certificate.
8. The bidder should quote their offer percentage less/above/at par in the financial bid only.
9. The bid for the work shall remain open for acceptance for a period of 180 days from the date of opening of bid. If any bidder/tender withdraws his bid/tender before the said period or make any modifications in the terms and condition of the bid, the said earnest money shall stand forfeited.
10. Security Period is 1 (one) year.
11. A Bank Draft of 10% of the Amount put to tender is to be submitted by the successful bidder, if the Bid value is less than 80% of the estimated amount put to tender before issuance of Work Order as Additional Performance Security.
12. The authority reserves the right to accept or reject any or all tender without assigning any reason
