GENERAL TERMS & CONDITION

01. Rates offered should include the cost of loading, unloading & stacking of the articles at delivery points i.e. in the Project's godown of Bandwan ICDS Project for which supply order will be issued and all other Incidental charges and expenses. The rates should be quoted in both words and Figures per piece of the article. No over writing will be allowed.
02. Each Tender must be accompanied with an earnest money of Rs.10, 000/- (Rupees ten thousand) only in the form of Bank Draft in favour of the Child Development Project, Bandwan ICDS Distric Project, Bandwan,Purulia. No other form of deposition will be accepted.
03. Successful Tenderer shall have to deposit security money to the tune of 5% of the Money value of the Work and execute a contract deed of Agreement with the Child Development Project Officer, Bandwan ICDS Project, Purulia on behalf of the Governor of West Bengal. The Security Money shall be deposited in the form of NSCs duly pledged in favour of Child Development Project Officer, Bandwan ICDS Project, Bandwan, Purulia /Bank Draft in favour of the Child Development Project Officer, Bandwan ICDS Project, Bandwan, Purulia.
04. The Earnest money deposited by successful Tenderer shall stand forfeited to Government without further reference in case of the Tenderer fails to furnish security money within prescribed period. Self attested copies of PAN Card, P.Tax, VAT clearance & Income Tax clearance Papers shall be attached with the tender paper otherwise the Tender will not be accepted.
05. The authority reserves the absolute right to appoint more than one supplier if the authority deems fit & convenient.
06. The deduction of Income tax and VAT from the bill will be made as per the government guidelines.
06. The Delivery of articles shall have to made within 7 days of receipt of supply order with strict following of the specification otherwise supply order may be treated as cancelled and the same will be purchased from the next lowest tenderer and the difference in price of the articles will be adjusted from the security deposit of the successful tenderer.
07. The requirement of articles and numbers of articles to be purchased solely depends on the availability of fund and need based.
08. The authority reserves the absolute right to accept or reject any tender including the lowest one without assigning any reason whatsoever. The decision of the Sub-Divisional Officer, Sadar-East, Purulia/Project Level Tender Committee forBandwan ICDS Project is final in regards to finalization of Tender.
