TENDER NOTICE

Sealed Tenders are invited from all the intending bonafide and reputed persons having experience in Interdistrict food lifting to act as "CARRYING /TRANSPORT CONTRACTOR" for carrying food stuff/materials related to ICDS Programme from FCI godowns (i.e. Charrah, Balarampur & Adra) to 21 ICDS Project godown situated at 20 blocks of Purulia.

1. Tender paper will be issued against application from the parties in a foolscap paper from District ICDS Cell, Purulia, Collectorate on all working days **between 11.00 A.M. to 3.00 P.M. from 16.03.2017 to 27.03.2017**
2. The last date of submission of Tender is **27.03.2017 up to 12.00 noon** at the issuing office and the Tender will be **open at 2.00 P.M. on the same day** in the office chamber of the Additional District Magistrate(SW), Purulia.
3. The period of Tender will be one year only from the date of execution of contract deed. Period may be extended as per decision of District Magistrate, Purulia.
4. The accepted Carrying/ Transport contractor will have to carry food stuff in such a manner that food stuffs are not found shortage or damages or whatsoever during transportation. If such cases are occurred, value of shortage or damage food stuffs will be recovered from the carrying/Transport contractor, from his pending bill or from his security deposit as per government rate. No transit loss is admissible.
5. Delivery of food stuffs should be made within 7(seven) days from the date of delivery from the authority concern to all ICDS Projects He should inform to the Officer about the progress of delivery of food stuffs at Projects godown. If he fails to give delivery within the stipulated period his tender will be rejected for public interest.
6. Weight of food stuffs at the time of delivery at Project godown be verified and short weight if any be mentioned in the challan by the consignee.
7. Attested copies of Pan Card /receipt or current income Tax return & P. Tax Clearance certificate & credential should be submitted along with the tender paper in sealed envelope.
8. Earnest money amounting to Rs.50,000/-(Rupees Fifty Thousand) only in the form of N.S.C./ K.V.P. or Bank draft duly pledged in favour of District Magistrate, Purulia will be accompanied with he tender paper in sealed envelope.
9. Successful tender will have to deposit Rs. 100000/-(Rupees One Lac) only as a security deposit by way of N.S.C.(National Saving certificate/ K.V.P. duly pledged in favour of the District Magistrate, Purulia at the time of execution of contract.
10. Accepted Carrying Transport Contractor should execute contract deed on Non-judicial stamp paper as per value of the contract.

11. If the accepted tenderer fails to execute deed of agreement and act as carrying contractor within the fixed date, the Earnest Money will be forfeited in favour of the Government.
12. The tender committee reserves the right to accept or reject any tender without assigning any reason whatsoever.
13. Tender will not be entertained if there is any over writing, absence of valid and current Income Tax, return or Pan Card, P. Tax Clearance certificate, credential in original and Earnest Money etc. in sealed envelope.
14. 2% Income Tax and other taxes/ duties as imposed by the Government will be deducted from the bill at source as per Government rules.

15. **Credentials:-**

Mandatory :-

- Handling of F&S / FCI food grains for a period of 10 years from the date of tender and at least transportation valued 5 Lac is to be attached with the tender.

Handling includes :- Loading, Unloading and transportations

Preference will be given to those parties having :-

- District Level Storage space of at least 1000MT in a single campus (if need be)
