e-Tender Notice

e-Tenders are invited from bonafied Self Help Groups of Purulia District, having credentials / experience in such work, for procurement of "Poustik Powder" under Additional Nutritional Support for severely malnourished children of ICDS Projects of Purulia Districts with following composition of "Poustik Powder" of 1100 gms per packet:

1. Wheat flour	450 gms.
2. Roasted Bengal gram flour	300 gms.
3. Roasted & crushed ground nut	150 gms.
4. Sugar	200 gms.

The "Poustik Powder" must be prepared by following all food safety norms and packed in air-tight condition in good quality sealed food-grade packets with net weight of 1100 gms. The "Poustik Powder" must remain fit for consumption by children for at least 90 days from the date of supply to the office of the concerned ICDS Projects. "Poustik Powder under Additional Nutritional Support (THR) for severely malnourished children supplied for ICDS Programme" must be printed boldly on the packets and the ingredients / composition of "Poustik Powder" , Batch no & Date of manufacture and the date by which it is to be consumed are must be printed on the packets. A sample packet of "Poustik Powder" is to be submitted to the District ICDS Cell along with certificate of quality from competent authority by 28.02.2018.

Supply is to be given to the Office/ Project godown of the concerned CDPO within 10(ten) days from in issuance of supply order. The packets must be in sound conditions and the ingredients must be as specified otherwise it will not be accepted. If the "Poustik Powder" became unfit for children consumption within 90 days from the date of delivery, the damaged packets must be replaced by the selected SHG, otherwise the cost of damaged food will be deducted from their pending bills.

e-filling of tender, the intending tenderer (SHG) may download the documents from the website <http://wbtenders.gov.in> and submit bid directly with the help of digital signature certificate and the samples with the certificate of quality are to be submitted to the District ICDS Cell along with certificate of quality from competent authority by 12 noon of 27.02.2018 .


The district authority reserves the right to accept or reject any tender without showing any reason whatsoever.

The rate for 1100 gms packet of "Poustik Powder" is to be quoted including transportation, tax and other charges as per prescribed format enclosed with this notice.
