NOTICE INVITING TENDER
**No.03/PSD-I/SS of 2019-20 of The Assistant Engineer, Purulia Sub-Division-I, Social Sector,
P.W.Dte.**

Sealed tenders are hereby invited in the tender form W.B.F. No. 2911 by the Assistant Engineer, Purulia Sub Division-I, Social Sector, P.W.Dte., from the eligible Contractors as per the detailing below:-

1. The Tender documents Consisting related NIT, specific Priced Schedule, Tender form 2911, and other documents, are available in the office of the Assistant Engineer, Purulia Sub-Division-I, Social Sector.
2. The bidders will have to follow the following steps:-
 - a. Submit application for tender documents as offline tenders.
 - b. Got permission for submission of the bid.
 - c. Download the tender documents from the website: <http://wbpwd.gov.in>.
 - d. Fill them up with quoting of rates and other requisite detailing as like offline tenders.
 - e. Sign all the documents in token of agreement of the conditions of the tender.
 - f. Enclose necessary Earnest money with them.
 - g. Submit them as offline tenders, in a sealed cover, within the time limit stated in the NIT. at the tender box, kept at the office of the undersigned.
3. Cost of tender form need not to be paid while submitting tenders, but payable for the required copies at the time of agreement, i.e. after acceptance.
4. The tenderers need to produce Valid Trade License from the respective Municipality, Panchayat etc., as the case may be for getting permission of tender documents. Non refundable copy need be submitted.
5. Copy of PAN Card, Copy of last return submitted to Ministry of Income Tax, Govt. of India and Acknowledgement receipt for assessment year 2017-18, Valid 15-digit GSTIN under GST Act, 2017, Profession Tax, Challan & Clearance certificate for the year 2018-19, Firm Registration, and credential of work performed, if any, need be submitted and necessary verification may be done with the original copies thereof.
6. Earnest money of amount mentioned in the annexure to be deposited in favour of **Executive Engineer, Purulia Division, Social Sector, P.W.Dte.** by Bank Draft. The Contractors having fixed security deposit, as per previous rule, are not allowed for exemption for any tender, w.e.f. 08-03-2014, as per Memo no:- 71/SPW/2014 dt. 03.03.2014, from Principal Secretary to the Government of West Bengal, Public Works Department.
7. Contract documents consisting of specification and terms and conditions for the work to be taken up and the condition of contract as laid down in W.B.F. 2911 need be complied with by the tenderers.
8. Vide Notification No:- **04-A/PW/O/10C-02/14, Dt:- 18-03-2015**, Specific credential certificate issued by Executive Engineer or by officer of similar rank only be entertained. **Payment certificate will not be treated as credential.**
9. No materials for construction will be issued departmentally. All materials including cement, steel, etc. is to be collected by the agency concerned. The agency shall have to take necessary approval from the E.I.C. before bulk procurement of each material. The materials need be approved by the Engineer-in-charge.
10. As per Memo No. 418/NW-1 dt. 20.07.2009 it is stated that Contractor have to purchase materials such as steel and cement of specified grade of IS specification as will be decided by E.I.C. from authorized dealers. Original cash memo are to be produced to the concerned Assistant Engineer for verification of related consumption, test certificate of steel/cement consuming in works- may be asked for, the cost of which shall be borne by the contractor.
11. Labour Welfare Cess @ 1% (one percent) of the value of the work is to be deducted from the bill as per circular issued vide no. 599A/VI-28/06 dt. 27.09.2006, of E.I.C. and Ex. Officio Secretary P.W.D. and P.W.D. (Roads) Department.
12. The undersigned reserves the right to reject any or all tenders without assigning any reason thereof.
13. Notwithstanding anything contained in this notice inviting tender, the other terms and conditions as laid down in the specific guidelines and rules will be binding upon all concerned.
14. As per memo no- 4608-F(Y) dt 18.07.2018 of the Additional Chief Secretary, Finance Department, Audit Branch, to the Government of West Bengal Additional performance security to be deposited in the form of Bank Guarantee from any Scheduled Bank before issuance of the work order@ 10% of the tendered amount from the successful bidder if the accepted bid value is 80% or less of the estimate put to tender. If the bidder fails to submit the Additional Performance security within seven working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor etc may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required. The Bank Guarantee shall be returned immediately on successful completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered/affected by provision of this Additional Performance Security.
15. In case of unscheduled holidays, on the aforesaid dates, the next working day will be treated as schedule prescribed date for the purpose.
