Sealed separate quotations is hereby invited (in prescribed documents) for Hiring one number Diesel Maruti Suzuki Swift-Dzire- LDi/ VDi/ ZDi/ ZDi plus or Maruti Suzuki-ERTIGA ZDi/ VDi/ LDi SHVS BS-IV or MHINDRA Bolero SLX/ ZLX/ Power plus ZLX BS-IV or MAHINDRA Scorpio Getway 2WD/ 4WD BS-IV of Advance Model (BS IV) car having public carrier licence for use of Assistant Engineer, Purulia Highway Sub-Division, P W (Roads) Directorate, Ranchi Road, Purulia.

1. ELIGIBILITY OF THE QUOTATIONER:

- i) The intending quotationer(s) must have to be the owner(s) of the vehicle which has been **purchased not before on 01.01.2015** or those who already applied for and also with advanced booking receipt for a new vehicle of specified model to any authorized dealer with specific quotation & can place the same within one month from the issue of the letter of acceptance.
- ii) The intending quotationer must have to obtain prior permission in writing from the undersigned.
- iii) Submitting an application on his / their letter head together with valid certificate (attested xerox copy) of clearance of Income Tax for the assessment year 2017-18, Pan Card, Blue Book of vehicle or Advanced booking receipt Residential with photo identity Proof, GST Registration number if Registered. (Not Refundable)
All original certificates to be shown at the time of submitting application.
- iv) Intending quotationer(s) will have to quote their rate for any of the above item for having a particular vehicle. In other word each quotationer will be allowed to offer rate for a particular item for a particular vehicle.

2. STATUS OF THE VEHICLE:

- i) The vehicle must have a public carrier licence at the cost and responsibility of the owner(s) and the make should be of advance model (BS-IV) Diesel Maruti Suzuki Swift-Dzire- LDi/ VDi/ ZDi/ ZDi plus or Maruti Suzuki-ERTIGA ZDi/ VDi/ LDi SHVS BS-IV or MHINDRA Bolero SLX/ ZLX/ Power plus ZLX BS-IV or MAHINDRA Scorpio Getway 2WD/ 4WD BS-IV. In case such licence is not obtained before submission to this office, the owner / tenderer(s) / Quotationer(s) will be bound to obtain such licence immediately (maximum period to be allowed is fifteen days) after acceptance of his / their offer, failing which the offer will stand cancelled and the Earnest Money will be forfeited to Govt.
- ii) Maruti (Model as mentioned) preferably first choice.
- iii) The vehicle must be insured against accident at the cost and responsibility of the owner(s).
- iv) All Taxes and other relevant charges as per Govt. Rule must have to be cleared up at the cost and responsibility of the owner(s) in due time.
- v) One good speed meter must have to be provided with the vehicle at the cost and responsibility of the owner(s) to show the Kilometerage of journey.
- vi) Public carrier licence as mentioned in Para 2(i) above should be applicable for all over West Bengal.


