**TERMS AND CONDITONS:**

1. The quotation is subject to the final acceptance of the Executive Engineer, P.W.D. Purulia Division, who reserves the right to accept the lowest one or reject any or all the quotations or part thereof without assigning any reason.
2. No extra claims whatsoever will be entertained after acceptance of the rate by the appropriate authority in any circumstances.
3. The rate should be inclusive of all taxes, carriage etc. and the rate should be quoted against the item of the work schedule attached with the quotation. The rate shall be in per Sq. ft for one or more nos of units.
4. The firms / agencies have to satisfy the undersigned about their financial and other resources and past experience in similar type of work involved.
5. The agency has to submit bill in duplicate in his letter head after executing the job satisfactorily. Payment will be made after successful completion of work and clearance of site and availability of fund.
6. Necessary deduction of I.T. & CESS will be made as per Govt. rules. No security deposit will be deducted from the bill of the agency.
7. As per Notification No. 4373-F(Y) dated 13.07.2017 of Principal Secretary, Finance Department, Audit Branch the following clause is incorporated in this tender and liable to be complied by the participant.
  - a) Bidders shall submit copy of
    - Valid PAN issued by the IT Deptt. Govt. of India.
    - Valid 15-Dight Goods and Service Taxpayer Identification Number (GSTIN) under GST Act 2017.
  - b) Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with provision of GST Act, 2017.
8. Statutory deduction by TDS is liable to be deducted as per provision of GST Act, 2017. Tax liability of the concerned works contract has to be borne as per prevailing GST Act, 2017 by the Agency.

10. Provision should be kept to maintain the said temporary structures till the vacating the said structures by the respective forces. The ground should be cleared after dismantling / removal of the temporary shed and to keep the ground in original condition.
