N.B All participant /Register Authorised representative are requested to be present in the chamber of the Assistant Engineer (PWD) Purulia Construction Sub-Division during opening of Tender. Assistant Engineer (PWD) may call SEALED BID after opening of the Tender to lower down the rate further. No objection in this respect will be entertained if raised later of any tendered who may not have been; present during opening of the tenders. The intending tenderers are requested to give special attention to the following points, which should be adhered strictly.

- i) All the certificated required for giving permission for purchasing the tender forms shall be produced in Original along with Xerox copy duly attested by appropriate and signed by the applicant.
- ii) In case of any firm the legal documents of legal authority of a member or members of the firm for signature in the tender.
- iii) Intending tenderers will have to produce valid I.T.C./S.T.C. and P.T.C. certificated and requisite credential all in original certificates as and when required original credential of similar nature of works amounting at least 40% value of the in a single work order prayed for.
- iv) Eligibility of contractors will be considered as per N.I.T.
- v) Receipt copy of Bank Draft will not be entertained.
- vi) All the contractors will have to drop their tenders with requisite Earnest Money, who have been allowed purchasing Tender forms otherwise he/they will be debarred from issuing any tender paper for one year under this Sub-Division.
- vii) All the participants or Tenderer must be present at the time of opening of Tender. Necessary Sealed Bid may be held after opening of tender on the same date. if anybody fails to attend his claims will not be entertained in future
- viii) Tender papers will not be issued to those contractors whose working performance in this division in the running tenders are not found satisfactory to the Engineer-In-Charge.
- ix) Application will be received from the Applicants only & no application will be received without proper authorization.
- x) The entire intending contractor will also have to produce License under the contract Labour(Regulation and Abolition) Act 1979 after issuing work order.
- xi) In addition to the recoveries made from the Bills further a Cess @ 1% of the cost of works shall be levied as notification dated 26.9.1996 of Ministry of labour, Govt. of india and in terms of order No 853-F dated 1.2.2006 issued vide Engineer-In-Chief and Ex. Officio PWD & P.W.(Roads) Department Circular No 599A/4M-28/06 dt. 27.09.2006.
- xii) Security Money will be released as per Notification No. 177-CRC/2M-57/2008 dated 12/07/2012. of secretary to the Government of West Bengal.
- xiii) All the participating tenderers / Bidders are requested to produce the Instruments of E.M.D. as stipulated in the N.I.T.as this should become the part of the Tender document vide order No. 4818/C.E./P.W.D. dt. 26.12.2013. Tenderers / Bidders who will not produce the said document shall be barred from participating in any further tender of this directorate for one year from the date of the N.I.T.
- xiv) Departments Memorandum bearing No. 547-W@1M-387/15 dt. 16.11.15 regarding suspension and debarment of Supplier, Contractor and Consultants will come in force as the situation arises & to be in treated as special terms & conditions of the contract & Should be the part of the contract documents.

xv) The Dispute Redressal Mechanism as contained in the general condition of contract for works has been engaging the attention of the Government for some time past. The present system of dispute redressal contained in Clause-25 of the General Conditions of Contract of the State Public Works Department read as Clause-25 Except where otherwise provided in the contract all questions and disputes relating to the meaning of the specifications, designs, drawings and instructions herein before mentioned and as to the quality of workmanship or materials used on the work or at any other question claim right matter or things whatsoever, in any way arising out of relating to the contracts designs drawings specifications estimates, instructions orders or these conditions or otherwise concerning the works, or the executions or failure to execute the same, whether arising during the progress of the work or after the completion or abandonment thereof shall be referred to the sole arbitration of the Chief Engineer of the Deptt should the Chief Engineer be for any reason unwilling or unable to act as such arbitrator such questions and disputes shall be referred to an arbitrator to be appointed by the Chief Engineer. The award of the arbitrator shall be final conclusive and binding on all parties to this contract. The award shall be a speaking one, i.e. The arbitrator shall recite facts and reasons arising in support of the award after discussing fully the claims and conditions of the parties. (This Clause ( viz no. 25) shall not be applicable and shall be treated to be deleted for contract upto Rs 100 lakhs( Rupee One Hundred lakhs ) in case of P.W.D. Vide G.O. No. PWD 1(7)-Adt/IM-10/81 pt dt. 6.1.1995 and Rs 10 Lakhs in case of I & W Deptt. (Vide G.O. No. 1626(8)-1A dt 23.11.2011))

(2) Existing Clause -25 as quoted above needed to be reviewed to protect the interest of the Government and the contractors Accordingly, the Governor is pleased to replace the existing Clause-25 with the following. Clause-25 . Except where otherwise provided in the contract all questions and disputes relating to the meaning of the specifications. Designs, Drawings and instructions herein before mentioned and as to the quality of workmanship or materials used on the work or at any other question, claim, right matter or thing whatsoever, in any way arising out of relating to the contracts designs, drawing specification estimates instructions, orders or these conditions or otherwise concerning the works or the executions or failure to execute the same, whether arising during the progress of the work or after the completion or abandonment thereof shall be dealt with as mentioned hereinafter. If the contractor considers any work demanded of him to be outside the requirements of the contract or disputes any drawings, record or decision given in writing by the Engineer-in-Charge on any matter in connection with or arising out of the contract or carry out of the work to be unacceptable, He shall be promptly within 15 days request the Chairman of the Dispute Redressal Committee in writing for written instruction or decision. Thereupon the Dispute Redressal Committee shall give its written instruction or decision within a period of three months from the date of receipt of the contractor's letter. The Dispute Redressal Committee in each of the Works Department shall be constituted with the following officials as members.

- 1 Additional Chief Secretary/principal Secretary/secretary of the Departmental Concerned Chairman
- 2 Engineer-in-Chief/Chief Engineer or any officer of equivalent rank of the Deptt Member
- 3 one Designated C.E/Engineer of the Deptt to be nominated by Deptt. Concerned Member Secretary and convenor.
- 4 One representative of Finance Deptt. Of the Govt. Not below the rank of joint Secretary member/ Financial Advisor in case of the works Department where FA system has been introduced. It is amendment of clause-25 as per finance Department Audit Branch no. 8182-F(Y) dt. 26.9.2012. This provision will be applicable irrespective of the value of the works to which the dispute may relate. this order will take immediate effect and be applicable to all the state Government Department.
