### 3 Eligibility of the Contractor:-

- (i) Having Credential in form of completion certificate for completing similar type of work for at least 40% of the amount put to tender within last **5(Five) years** in a single work (Similar type of work)..
- (ii) Credential from any Govt. /Semi. Govt. and from autonomous bodies as bonafide contractor/ agencies will be entertained for schemes having completion certificate as proof of credential. While e-filing of tender, the intending bidder may download the tender documents from the website [www.wbtenders.gov.in](http://www.wbtenders.gov.in) directly by the help of digital signature certificate.

4. The Tenderers should submit the copies of following papers duly attested by competent authority as technical bid documents -

- a) PAN / TAN (as applicable)
- b) Up-to-date Profession Tax Return & Profession Tax Registration Certificate.
- c) Copy of valid 15 digits GSTIN under GST Act. 2017 and vide notification no. 5050-F(Y) Dated; 16.08.2017 of Finance Department, Audit Branch to the Govt. of West Bengal.
- d) Up-to-date Income Tax Return,
- e) Credential Certificate for work during last 5 years from the date of issue of the tender notice for work of similar nature under the authority of State / Central Govt., State / Central Govt.

- 4). Registered partner Ship Deed in case of partnership firm has to be submitted. The company shall furnish the article of Association and memorandum. Where an individual person hold a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of Such company or the partners of such firm to upload such tender, (Non-Statutory Documents).
5. No Adjustment of Price OR Price Escalation of any kind will be allowed. C
6. No Mobilisation Advance and Secured Advance will be allowed.
7. Joint venture will not be allowed.
- 8. Payment will be made as per availability of fund.**
9. No arbitration is allowed in this contract.
10. A penalty @ 0.1% (Zero point One percent) of the value of work may be imposed on per day delay. In case of inordinate delay, the undersigned reserves the right to cancel the work order & forfeit the earnest money of the contractor; in that case, claim for payment of work already executed may not be entertained and the contractor may be blacklisted.
11. 10 (Ten) % value of the work will be retained as security deposit (including 2% earnest money) which will be released on completion of secured period if condition of road found ok..
12. No material will be issued from the department'
13. Constructional labour welfare cess @ 1% of the bill value will be deducted from the bill.
14. For any kind of exemption, on the above mentioned required documents, the bidder shall have to submit authenticated document from competent authority, in support of his claim, at the time of submission of Technical Bid. No claim on a later stage will be entertained. However, the final decision regarding this will be made by the Authority
15. Contractors shall have to comply with the provinces of A) the contract labour (regulation Abolition) Act. 1917, B) apprentice Act 1961& C) Minimum wages Act. 1948 of the notification there of or any laws relating thereto and the rules made and order issued there under form time to time.
16. The Schedule of Rates as given in BOQ.
17. The Earnest Money May be Forfeited-
  - a) If the Bidder withdraws the Bid during the period of Bid validity of 180 days from the date of dropping.
  - b) In case of a successful Bidder, if the Bidder fails within the specified time limit to sign the agreement.
  - c) During scrutiny or at any stage of bidding or even after award of contract, if it is come to the notice to tender inviting authority the credential or any other papers found incorrect/ manufactured/ fabricated and If any documents / Formats / B.O.Q. are found in altered / tempered shape other than the shape.
18. The authority reserves the right to cancel the NIT due to unavoidable circumstances and for the no claim will be entertained.
19. Before submission of tender, the tenderer shall have to acquaint by actual visit to the site as regards prevailing condition and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local condition of labour material transport electricity water etc.
20. Contractor has to execute the work on strict supervision of the Engineer/Engineer in Charge (EIC).
21. Decision of the authorities will be final binding on contractor in case of any type of dispute.
22. All tools, plants & machineries including vibratory, etc. required to execute the Contract, has to be arranged by the Contractor at his own cost.
23. The works are time bound project and time of completion of work should be strictly followed.

It is notified for general information that the additional performance security shall be obtained from the successful bidder, if the acceptance bid value is more than 20% less than the estimated amount put to tender. The additional performance security shall be equal to 10% of the tendered amount and it shall be submitted in the form of Bank Guarantee from any schedule bank as per specified format will be given to L1 bidder before issuance of Work order. If the bidder fails to submit the additional performance security within 7 (Seven) working days from the date of issuance of letter of acceptance, his earnest money will be forfeited. The said bank guarantee shall be valid up to the end of the contract period and shall be renewed accordingly, if required and the same shall be returned immediately after successful completion of the contract. If the bidder fails to complete the work successfully, the said security shall be forfeited at any time during the pendency of contract period after serving proper notice to the contractor.


